The Directory lists those DBE firms with current certification by the New Hampshire Department of Transportation. This publication is provided for information purposes only, and is subject to revision. Periodic updates indicating any change will be published on the NHDOT web site (see below).

The types of work listed in the Directory are those proposed by each DBE. The New Hampshire Department of Transportation does not certify or pre-qualify a DBE for the types of work proposed, and accordingly, does not guarantee the capability, dependability or availability of any DBE listed; nor can it be assumed that any DBE listed qualifies as a Regular Dealer (supplier) in materials.

Prior to bid letting, out-of-state DBE firms must be concurrently certified by the New Hampshire Department of Transportation and their home-state DOT/and or other appropriate certifying agency, in order for their participation to count toward the contract DBE participating goal.

A DBE firm that is subcontracting or acting as a material supplier on a Federalaid highway project must perform a commercially useful function. Failure to perform a commercially useful function may be grounds for decertification.
